## **SBA's Deadline is Oct. 14 for Physical Damage Disaster Loan Applications in Pennsylvania**

**ATLANTA** – The U.S. Small Business Administration reminds homeowners, renters, businesses and non-profit organizations of the deadline to submit disaster loan applications for damages due to severe storms and flooding between June 26 and July 21, 2013. The deadline to apply for physical damage is **Oct. 14, 2013**.

Low-interest disaster loans are available in Beaver, Butler, Lawrence and Mercer counties in **Pennsylvania**; Columbiana and Mahoning in **Ohio**.

Loans up to \$200,000 are available to homeowners to repair or replace damaged or destroyed real estate. Homeowners and renters are eligible for loans up to \$40,000 to repair or replace damaged or destroyed personal property. Businesses and non-profit organizations of any size may borrow up to \$2 million to repair or replace damaged or destroyed real estate, machinery and equipment, inventory, and other business assets.

For small businesses, small agricultural cooperatives, small businesses engaged in aquacultural, and most private non-profit organizations of all sizes, the SBA offers Economic Injury Disaster Loans (EIDLs) to help meet working capital needs caused by the disaster. EIDL assistance is available regardless of whether the business suffered any physical property damage.

Interest rates are as low as 1.875 percent for homeowners and renters, 2.875 percent for non-profit organizations and 4 percent for businesses with terms up to 30 years. The SBA sets the loan amounts and terms based on each applicant's financial condition.

Applicants may apply online using the Electronic Loan Application (ELA) via SBA's secure website at <https://disasterloan.sba.gov/ela>.

The filing deadline to return applications for physical property damage is **October 14, 2013**. The deadline to return economic injury applications is **May 14, 2014**.
